

**Sip...Rip...Ultimate Trip Promotion
Official Rules**

Dates: July 1, 2020 – October 31, 2020

NO PURCHASE REQUIRED TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID OUTSIDE DESIGNATED EXCHANGES ON U.S. MILITARY BASES IN THE UNITED STATES, GERMANY, ITALY, KOSOVO, SOUTH KOREA, MAINLAND JAPAN, OKINAWA, PUERTO RICO, HONDURAS, AND KWAJALEIN. VOID IN RHODE ISLAND, NEW YORK, FLORIDA AND WHERE PROHIBITED OR RESTRICTED BY LAW.

2. **Eligibility:** The Sip...Rip...Ultimate Trip Promotion (the "Ultimate Trip Game") is open only to authorized Exchange patrons that are citizens of the 50 United States, Puerto Rico and the District of Columbia (excluding all United States territories and possessions that are not U.S. military bases, and Rhode Island, New York and Florida), 18 years or older that are U.S. Forces members and family members who are Exchange Authorized Patrons at designated Exchanges on U.S. Military Bases in the United States, Germany, Italy, Kosovo, South Korea, Mainland Japan, Okinawa, Puerto Rico, Honduras, and Kwajalein.

Employees of Sponsor, its concessionaires, contractors, and representatives providing in-store service or working in an Army & Air Force Exchange Service ("AAFES") facility, Administrator, Promotional Participant and each of their respective parent companies, subsidiaries, affiliated entities, and affiliates, distributors, companies involved in the implementation and execution of the Ultimate Trip Game ("Promotion Entities") and each of their respective immediate family members (i.e., spouse, parent, child, sibling and the "steps" of each) and persons living in the same household of each are not eligible to participate in the Ultimate Trip Game. Void where prohibited or restricted by law. By participating in this Ultimate Trip Game, an individual who meets the eligibility requirements, and enters the Ultimate Trip Game, agrees to be bound by these official rules ("Official Rules") and that the decisions of Sponsor and/or Administrator shall be final and binding in all matters pertaining to the Ultimate Trip Game.

An "Entrant" is an eligible person who submits an entry in accordance with these Official Rules.

3. **Promotion Period:** The Ultimate Trip Game begins at 12:00 a.m. Eastern Time ("ET"), July 1, 2020 and ends at 11:59 p.m. ET, October 31, 2020 (the "Promotion Period"). Administrator's computer is the official time-keeping device for the Ultimate Trip Game.
4. **Agreement to Official Rules:** By participating in the Ultimate Trip Game, Entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of the Sponsor and Administrator, which are final and binding in all matters related to the Ultimate Trip Game.

5. **How to Enter:** You may enter the Ultimate Trip Game only via the entry methods described below. Proof of depositing entry in mail is not considered proof of delivery or receipt. No photocopied or mechanically reproduced entries will be accepted. Illegible, incomplete and duplicate entries will be disqualified. Entries will not be accepted from post office boxes. All entries become the property of Sponsor and will not be acknowledged or returned.

a) **Purchase a 30 oz. Beverage:** During the Promotion Period, visit a participating Subway® store located at designated Exchanges on U.S. Military Bases, and purchase a 30 oz. beverage. Locate the Ultimate Trip Game piece (“Game Piece”) on the cup. If the participating Subway store located at designated Exchanges on U.S. Military Bases does not sell 30 oz. beverages, purchase a can or 20 oz. bottle beverage and you will receive a Game Piece. Peel the Game Piece to reveal if you have won a Prize (defined herein). If you are a potential winner, see Prize Claim Instructions below. All potential winners are subject to verification before any Prize will be awarded.

b) **Mail-In Alternate Method of Entry:** To request a Game Piece without making a purchase, send a self-addressed envelope with proper postage, and mail it in an envelope with proper first-class postage to "Sip...Rip...Ultimate Trip Promotion," P.O. Limit: One (1) request per envelope. All mail-in requests must be handwritten and must be postmarked by October 31, 2020 and received by November 16, 2020. Administrator will fulfill a Game Piece within twenty-one (21) business days of receiving the request, by mail. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, misdirected or postage-due entries, which will be disqualified. Peel the Game Piece to reveal if you have won a Prize (defined herein). If you are a potential winner, see Prize Claim Instructions below. All potential winners are subject to verification before any Prize will be awarded.

If it is discovered that an Entrant has registered or attempted to register more than once using multiple identities or any other method of unauthorized entry, all in Sponsor’s and/or Administrator’s sole and absolute discretion, all of that Entrant’s entries will be declared null and void, Entrant will be disqualified from the Ultimate Trip Game and any prize that Entrant might have been entitled to receive will not be awarded to him/her. Entries that are late, lost, illegible, duplicated, mechanically reproduced, contain false information, damaged, misdirected, mutilated, garbled or incomplete, altered or otherwise irregular in the sole discretion of Sponsor and/or Administrator, that have been submitted or generated using robotic, programmed, script, or any other automated means, or illicit means, or do not conform with or satisfy any or all of the conditions set out in the Official Rules, as determined by Sponsor and/or Administrator in its sole and absolute discretion, may be judged void and disqualified.

6. **Prize Claim Instructions:** If you are a potential winner of a Type A Prize or Type B Prize (as outlined in Section 9), locate the code (“Code”) on the Game Piece and visit <https://www.exchangesubwaypromos.com/>. Follow the links to enter your Code. Potential Type A Prize and Type B Prize winners may select a participating Subway® store located at designated Exchanges they would like to pick up their Type A Prize or Type B Prize. Alternatively, the Administrator or Sponsor may send the applicable Type A Prize or Type B Prize to a potential Type A Prize or Type B Prize winner via mail to an address provided by the potential winner. Any Type A Prize or Type B Prize sent via the mail is to be deemed delivered to the applicable potential winner upon shipment and Released Parties shall have no liability or obligation concerning undelivered or damaged Type A Prize or Type B Prize.

All prize Type A Prize claims and Type B Prize claims must be received by December 31, 2020 at 11:59 p.m. ET, or potential winner forfeits the Prize, which will remain un-awarded. Each potential winner should retain a photocopy of his/her winning Game Piece. Facsimiles, photocopies and

reproduced Game Pieces are not eligible. Each potential winner must comply with these Official Rules and execute all required documentation in order to claim the Prize.

Each potential winner must comply with these Official Rules and execute all required documentation in order to claim Prize.

7. **Ultimate Trip Game Prize Selection:** Receiving, claiming or redeeming a Prize is contingent upon compliance with these Official Rules. Administrator is an independent judging organization whose decisions as to the administration and operation of the Ultimate Trip Game and the selection of potential winners are final and binding in all matters related to the Ultimate Trip Game. There will be no more than six hundred and five thousand seven hundred (605,700) random winning Game Pieces distributed during the Promotion Period while supplies last. **NOT ALL PRIZES ARE GUARANTEED TO BE AWARDED.** You will be a potential winner of the Prize indicated on the Game Piece. The approximate odds of winning each prize as of the beginning of the Promotion Period are set forth in the table in Section 9. The numbers of prizes available to be won will diminish, and the odds of winning a specified Prize may change, as the Promotion progresses and as Prizes are claimed and awarded.

Not all prizes may be awarded dependent upon the number of entries and which Game Pieces are randomly provided to the Entrants and the number and type of game pieces printed. TRIP CONDITIONS

* Trip package, up to \$25,000, includes round trip, coach-class air transportation for Prize winner and travel companions from a major airport near winner's home (determined by Sponsor in its sole discretion) to a city determined by winner; accommodations at a hotel determined by Sponsor in its sole discretion; ground transportation to and from destination airport and hotel (if applicable); various activities depending on selected city; and travel agent services. The Exchange Gift Cards may be subject to terms, conditions and policies specified by issuer. item. Each Subway® Card will be voided if it is used without permission, altered, or defaced. The physical Subway® Card is usable up to its balance only to purchase goods or services at participating Subway® restaurants in the U.S. and Canada, at Exchange-operated restaurants overseas, online at www.subway.com, or through the Subway® App.

PRIZE LIMITATION: Each Entrant may only win one (1) Type A Prize and one (1) Type B Prize.

- 11. Publicity:** Except where prohibited by law, participation in the Ultimate Trip Game constitutes Entrant’s consent for Sponsor and its designees to use Entrant’s name, likeness, Prize information, city and state of residence for advertising and promotional purposes in any media without further consideration.

General Conditions:** In the event that the operation, security, or administration of the Ultimate Trip Game is impaired in any way for any reason, including, but, not limited to, fraud, virus or other technical problem (including technical errors related to computers, servers, providers, printers, printing or telephone or network lines), the Sponsor may, in its sole discretion, either: (a) modify or suspend the Ultimate Trip Game to address the impairment and then resume the Ultimate Trip Game in a manner that best conforms to the spirit of these Official Rules; or (b) cancel the Ultimate Trip Game not award the Prizes. The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Ultimate Trip Game or to be acting in violation of the Official Rules of this or any other promotion, or in an unsportsmanlike or disruptive manner. - 13. Release and Limitations of Liability:** Except where prohibited, by participating in the Ultimate Trip Game, winners and Entrants agree to release and hold harmless Sponsor, Administrator, Asher Agency, Subway® restaurants, Subway® franchisees, Subway® franchisors, SFAFT, Franchise World Headquarters LLC, Doctor’s Associates LLC, Subway IP LLC, Merkle Inc., and their respective parents, subsidiaries, affiliated entities, affiliates, promotional partners, prize partners, agents and agencies, and the officers, directors and employees of them (the “Released Parties”) from and against any claims made by any potential winners, winners and Entrants or any other third parties related in any way to the operation of the Ultimate Trip Game, as well as any other claims, damages or liability due to any injuries, damages or losses (whether alleged, threatened, or actual) to any person (including death) or property of any kind resulting in whole or in part, directly or indirectly, from participation in the Ultimate Trip Game or any related activity,

including, but not limited to: (a) unauthorized human intervention in the Ultimate Trip Game; (b) technical errors related to computers, servers, providers, printers or telephone or network lines; (c) printing errors; (d) errors in the administration of the Ultimate Trip Game or the processing of entries; (e) late, lost, or undeliverable mail; or (f) injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from Entrant's participation in the Ultimate Trip Game or receipt, use, or misuse of any Prize. Entrant further -agrees that in any cause of action brought by an Entrant, the Released Parties' liability will be limited to Entrant's cost of entering and participating in the Ultimate Trip Game and in no event shall the Released Parties be liable for attorneys' fees. As a condition of entering the Ultimate Trip Game, each eligible Entrant gives consent for the Sponsor to obtain and deliver his or her name, address and other information to third parties for the purpose of administering this this Ultimate Trip Game and to comply with all applicable laws, regulations, and rules. Any information eligible entrant provides to the Sponsor may be used to communicate with Entrant in relation to this Ultimate Trip Game or on an Ultimate Trip Game winner's list.

By entering the this Ultimate Trip Game, each eligible Entrant agrees to the publication, reproduction and/or other use of his/her name, address, voice, image, statements about the Ultimate Trip Game, photograph and/or other likeness without further notice or compensation, in any publicity or advertisement carried out by or on behalf of the Sponsor, solely regarding the Ultimate Trip Game, including, but limited to: print, broadcast, the internet (including social media), and on the Ultimate Trip Game winners' list.
